ACKNOWLEDGEMENT AND ASSUMPTION OF RISK

I (parent or guardian) _____ on behalf of _____ UNDERSTAND AND AGREE that there is potential risk for injury involved in the training and participation of any physical activity. I further understand and agree that participating in hockey is a potentially dangerous activity. Bumps, bruises, scrapes and soreness are commonplace, and most participants will encounter this sort of minor injury from time to time. More serious injuries are possible, including sprains, strains, twists, cramps, fractured bones, broken bones, torn ligaments and injuries of similar magnitude. Participation also includes possible exposure to and illness from infectious and communicable viruses and diseases including influenza and COVID-19. While particular rules and guidelines may reduce the risk associated with participation, the risk of serious illness and death does exist.
